 - BRIC & FMA
 - i. Windows to apply will open September 30th – November 14th
 1. Letter of support is required; will check to see if project is required to be on the PPL to be submitted to the State
 - ii. ADD NOTICE OF INTEREST – closes next week
 - iii. Funding has doubled over the past year from 1 billion to 2.295 billion for BRIC
 - iv. FMA up to 800 million in funding
 - WebEOC Project Submission – currently only have 5 projects in; would like to see more projects added to the list (allows more projects to be eligible for funding).
 - i. Score sheet has been updated
 - ii. 5-6 members on the scoring committee
 - iii. Scores are based on an average; group submits scores to Ronnie, and then we meet to discuss the different scores
 - iv. Projects are eligible for rescoring – can add or remove/update information; costs changes can also be reason to submit for a rescore (only costs that are submitted with the projects will be covered for funding – municipalities will have to cover the rest of the cost if it's not up to date in the project submission)
 1. Add note on what changes were made during resubmission as well as if projects are removed all together
 2. If projects have been on the PPL for 5+ years, then they will need to be resubmitted
