

From the Inspector General

Greetings from your Inspector General! In addition to updating you on some of our activities (see left side), in this edition of our Newsletter, **I'm asking for your assistance in where to focus our efforts in the up-coming year**. The Office of Inspector General exists to help make government better, promote accountability, and prevent fraud, waste, and abuse. A big part of accomplishing this mission involves conducting audits of organizations and business processes. In planning our FY 2016 audits, we are currently conducting a risk assessment and would appreciate your input.

A risk assessment attempts to identify and analyze relevant risks or challenges to the achievement of organizational objectives, safeguarding of assets, and compliance with budget and other laws and regulations. Risks are often described as those things you worry about or that keep you up at night. Risks/vulnerabilities generally occur due to lack of any of the following:

- Segregation of duties,
- Clear guidance or policies in place,
- Adherence to policies and procedures,
- Documentation/monitoring,
- Resources to do the job,
- Staff training, knowledge, or expertise,
- Security over sensitive information, or
- Proper supervision/oversight.
